 5. Auction bid document (AUCBID).
 6. Auction results document (AUCRES).
 7. TSO reverse auction document (REVAUC)
 8. General capacity document (CAPDOC).
 9. Secondary market rights transfer document (TRAADV).
- Part II: Gas trading process.
 - This part contains all the messages used to transmit information related to:
 1. Gas purchase or sale offers document (OFFERS)
 2. Capacity request document (REQUEST)
 3. Capacity request confirmation document (REQRES).
 4. Gas requirements declaration document (GASDEC)
 5. Gas requirements confirmation document (GASCON)
- Part III: Nomination and matching process
